C. I ack	knowledge that at least 24 hours before the scheduled abortion I have received a
physic	cal copy of each of the following:
	. A medically accurate depiction, illustration, or photograph of a fetus at the probable gestational age of the
	fetus I am carrying.
	. A written description of the medical procedure that will be used to perform the abortion.
	. A prenatal care and parenting information pamphlet.

D. If any of the documents listed in paragraph C were transmitted by facsimile, I certify that the documents were clear and legible.

E. I acknowledge that the physician who will perform the abortion has orally

described all of the following to me:

- . The speci c risk to me, if any, of the complications that have been associated with the procedure I am scheduled to undergo.
- . The speci c risk to me, if any, of the complications if I choose to continue the pregnancy.
- F. I acknowledge that I have received all of the following information:
  - . Information about what to do and whom to contact in the event that complications arise from the abortion.
  - . Information pertaining to available pregnancy related services.
- G. I have been given an opportunity to ask questions about the operation(s) or procedure(s).
- H. I certify that I have not been required to make any payments for an abortion or any medical service before the expiration of 24 hours after I received the written materials listed in paragraph C, or 24 hours after the time and date listed on the con rmation form if the information described in paragraph C was viewed from the state of Michigan internet website.
